

### Reflections On SBC 2024 – Indianapolis

Indianapolis is one of the cities in the Midwest that I've never visited. I was impressed with the beauty of the city and especially its location along the banks of the White River. The convention center located in the downtown district was very convenient, with hotels and eating establishments within walking distance. It was an enjoyable experience and local hospitality was magnificent.

Oftentimes, two-day conventions can be wearisome, however there is something inspirational about joining with Southern Baptists from across the country to fellowship, worship, and conduct the business of the SBC. There were several highlights to this year's meeting that I would like to share.

**Bart Barber** as president has served with grace and dignity mixed with an abundance of humility to lead Southern Baptists over the past two years. He did an excellent job moderating the meeting and addressing the concerns of the messengers while keeping us focused on the main thing. My hat is off to him for his godly spirit, and I am grateful for his service to Southern Baptists. Well done, sir! I pray for Clint Pressley, our new president that he will lead with the same spirit of humility and grace.

For those of us in the west, **Dr. Jeff Iorg** is no newcomer to leadership at the executive level in the SBC. During his tenure at Gateway Seminary, we observed his visionary approach to training young leaders for ministry in our churches. He took on the monumental task of relocating an established seminary from one location to another in California without compromising the mission. I am proud to call him a friend and excited about the future of the SBC as he steps up to lead the Executive Committee. I believe all Southern Baptists can rally around his vision to remember that "The Mission Matters Most!"

The worship moments throughout the two days of meetings were led by **Dr. Joseph Crider**, dean of the School of Church Music and Worship at Southwestern Baptist Theological Seminary. He was joined by vocalists from Southwestern A Capella and members from the music ministry of First Baptist Church Farmersville. They masterfully projected the focus of worship on Christ and lifted our hearts to the throne of grace. What a pleasant experience to join our voices in praise to our Heavenly Father and His Son, our Savior!

It was encouraging to celebrate the increase of baptisms. Statistics over the past 10 years have shown a downward trend that needs to be reversed. Thirty-five of our forty-one state conventions which includes Alaska, have seen an increase in baptisms and I pray that trend will continue.

Perhaps, the most encouraging and celebratory moment of the entire two days was the Sending Celebration. The IMB invited messengers to celebrate with them the sending of 83 new missionaries to some of the most unreached regions of the world. Most of them are going to dangerous places that are resistant to the gospel and requires them to be discreet and keep a low profile. For that reason, we could not see their faces, but are obligated to pray for them. We pray for their effective engagement with a new culture, new language, new people and for God's protection in the face of governmental opposition.

This is the reason Southern Baptists come together with a cooperative spirit to blend our efforts and resources in one sacred effort to take the gospel to the ends of the earth. Our theme for the convention this year was based on Romans 15:5-6 - **One Mind-One Voice.** May that continue to be the heartbeat of Southern Baptists as we seek to fulfill the Great Commission.

### Should Ministers Participate in Social Security and Medicare.

To exempt or not to exempt that is the question?

Answers range from absolutely yes to absolutely no. This article provides a brief impartial assessment looking at factors such as the degree of secular employment, individual financial understanding, and the degree of personal discipline in the areas of investing and risk management.

When entering vocational ministry a "tax qualified" pastor or minister must evaluate whether they want to subject wages earned from such work to Social Security and Medicare tax. This crucial decision must be made within two years of entering ministry and it is generally irrevocable.

Currently the federal government collects taxes under two primary methods. The most common, known as the Federal Insurance Contribution Act (FICA), is used in a typical employer-employee relationship. The other is for self-employed individuals and is known as the Self-Employment Contributions Act (SECA). Churches are a unique category where pastoral ministers are deemed to have dual status. Pastoral ministers can file their federal income tax as an employee of the church (FICA). However, for Social Security and Medicare they are treated as self-employed and fall under the (SECA) classification. Technically, the church is not allowed to pay the pastors Social Security and Medicare taxes because of their tax-free status. Churches can, and often do, pay ministers the 7.65% allowance in additional wages to provide parity to (FICA) employees.

So is it worth the savings of a 15.3% tax on wages including any housing/parsonage allowance to exempt out of Social Security and Medicare? A truly objective answer is not a simple"yes" or "no" but is dependent on individual factors. It is important to realize that simply not wanting to pay the tax is insufficient justification. There must be a conscientious objection on the part of the minister to receiving public or private insurance. Some may site a moral objection to using ministry-earned monies to pay into a social government system. Others may use a stewardship argument, claiming that government is a bad manager of resources.

There are specific things to be considered before opting out of Social Security and Medicare taxes through the filing of IRS form 4361:

- 1. Does the Minister have Earnings from Secular Employment? Only pay associated with ministry is exempt. If the minister is bi-vocational there may be a greater benefit to exempting out of the tax on ministry wages.
- 2. Objectively Evaluating a Ministers Motivations and Rationale. Does the minister truly have a conscientious objection based on religious convictions to exempt out or is it primarily motivated by self-serving financial purposes?
- 3. Does the Minister have alternative protections and savings in place to compensate for exempting out? Ministers will need more extensive personal retirement savings and will also need to look at things like private disability insurance and other long-term care costs. An analysis by Crown Financial Ministries indicated that a retired minister would need additional pay between \$30-\$40,000 annually to effectively replace the lost benefits from exempting out of the Social Security and Medicare system.

While this article does not provide an exhaustive list of things to consider it does encapsulate the core issues.

Given the seriousness and generally permanent nature of the decision to exempt out of Social Security and Medicare tax, any such decision should be weighed with much prayer and personal reflection.


